ENTRY CONDITIONS

1. NOMINATION FEES

- (a) Registered Bulls \$200 + GST
- (b) Herd Bulls \$200 + GST

2. Maximum age for all sale bulls is 42 months.

3. The following are to be completed, signed and received by mail or email with the relevant nomination fees to Elders Rockhampton by the closing date specified above.

- (a) Signed copy of this Conditions of Entry document
- (b) Nomination Form
- (c) All Nomination Fees

4. REGISTERED BULLS

- (a) A Registered Bull must conform to the Standard of Excellence (Clause 23 of the Constitution).
- (b) Registered bulls are to be fully registered with the Society before close of nominations.
- (c) All Registered bulls must exhibit individual firebrand identification and year brand as quoted on the nomination form.
- (d) Bulls that are Calf Recorded but not fully registered can only be nominated as Herd Bulls.

5. COMMERCIAL (HERD) BULLS

- (a) Commercial, unregistered Bulls may be entered as "Herd Bull"
- (b) Herd bulls cannot be described as "Eligible for Registration" in the sale catalogue.

6. Registered and Herd Bulls may be mixed within the catalogue.

7. All bulls offered for sale will be catalogued and are to be sold in that order.

8. Substitute lots will not be offered in the event of withdrawals after the 26th of July and before the Catalogue goes to print.

9. PARENTAL VERIFICATION BY DNA

All Bulls born after 1st of April 2022 that are to be sold as "Registered" must have at least Sire Verification.

- (a) For the 2024 sale a check box will be included in the catalogue as follows, Registered with "Sire" and/or "Dam" verification by DNA.
- (b) A copy of DNA Test results must be forwarded to Elders Rockhampton by the 19th of July for inclusion in physical catalogue.

- (c) Results after this date will only be displayed on the Supplementary Sheet.
10. Prior to penning at the saleyards, all bulls are to have been paint branded with their designated lot number and carry the supplied lot number ear tag in the near-side ear.
11. **TERMS AND CONDITIONS OF SALE**
The CQ Invitational Droughtmaster Sale will adopt the ALPA Stud Stock Terms and Conditions of sale with A Guarantee of Fertility Clause included.
12. **AGENTS**
(a) Participating agent is Elders Rural Services.
(b) The draw will be conducted randomly by the selling agent at Elders Rockhampton on Friday, 26th July.
13. **REBATES**
(a) A rebate of 3 percent will be paid to approved Outside Agents. The rebate will be charged to vendors on a pro rata (per bull) basis on all lots sold or passed in.
(b) Any costs associated with Outside Agents will be deducted from the Vendor's sale proceeds on a pro rata basis.
14. **AFFILIATED STUDS**
Studs owned by immediate family members may sell either consecutive or mixed within the drafts.
Written requests need to be lodged prior to the draw.
15. **WITHDRAWALS**
Withdrawal of any lot or lots must be notified to the Sale Committee at least 48 hours prior to the sale.
16. **CHILDREN IN SALEYARDS**
Children under the age of 14 must be accompanied by an adult whilst in the saleyards area and are NOT permitted in the sale ring. The CQ Invitational Droughtmaster Bull Sale Committee, and the Selling Agents are not responsible for any injury sustained by persons whilst at the saleyards leading up to, during, or after the sale.
17. **HEALTH REQUIREMENTS**
Vaccinations - The following vaccinations are **compulsory**
(i) Trivalent (3 germ blood) Tick Fever Vaccine (at least 60 days prior to sale date)
(ii) "5 in 1" or "7 in 1" Vaccine
(iii) Ephemeral Fever (3 Day) Vaccine
18. **A National Cattle Health Declaration is to be provided to the agent.**
19. **VETERINARY REQUIREMENTS**
ACV Bull Soundness Evaluation
(a) All bulls must undergo and pass the ACV Bull Soundness Evaluation for Scrotal, Physical & Semen by an ACV Accredited Veterinarian within **60 days** of the sale.
Mouthing is optional.
Scrotal
• 18 to 24 months – Minimum 32cm
• 24 months and over - Minimum 34cm
Physical
• Only a "P" or "Q" is acceptable
Motility
(b) Bulls with semen motility less than 60% are not eligible for sale unless they have a morphology test which returns a result of 50% or greater normal sperm.
Morphology
(c) *The Morphology section is optional*, but if evaluated the bull **must pass**.
20. **SEMEN RETENTION**
(a) Any offers of free semen, retention of share of bull, or semen rights for in herd use must be declared in the nominations, for inclusion in the catalogue.

21. TICK TREATMENTS

- (a) All sale lots originating from the tick-infested area will need to undergo a **DPI Approved Tick Treatment** prior to the sale and be **presented tick free**.
- (b) A completed Cattle tick – meeting my general biosecurity obligation (GBO) form will need to be presented to agent on arrival at the saleyards.
- (c) In the event of a bull failing to clear for ticks at Gracemere Saleyards following the sale, the vendor will be responsible for all associated reasonable costs in relation to feeding and dipping due to the failure to clear the tick inspection.

22. ULTRASOUND SCANNING

Results are to be provided to Elders Rockhampton by Thursday, 17th of October.

23. PASSED IN BULLS

- (a) Passed in bulls are not to be sold for less than the upset price after the sale.
